### Financial Accountability

*Mother's Roots Initiative* maintains strong financial management practices to ensure that all funds are used responsibly and in alignment with our mission. Our financial oversight includes:

- Board-level review of financial reports and budgets
- Internal financial controls and recordkeeping procedures
- Compliance with applicable nonprofit laws and reporting requirements
- Regular review of expenditures aimed at ensuring funds directly support programs and operations

The Board of Directors is responsible for overseeing the organization's financial health and ensuring that funds are used in accordance with donor intent and the organization's mission.

### Use of Funds

Funds received by *Mother's Roots Initiative* are used to support:

- Early childhood immunization & screening program
- Antenatal and community health initiatives
- Community outreach and engagement
- Program development and evaluation
- Organizational operations necessary to sustain and grow our impact

Our goal is to direct majority of resources received toward *program activities that directly benefit mothers and children*.

All donations made to Mother's Roots Initiative are used to advance our mission. Unless otherwise specified by the donor, contributions may be allocated to areas of greatest need to ensure that programs remain effective and sustainable.
